Joining the Key Research Profile Areas, Ph.D. scholarship holders will be part of highly vibrant and international research networks in our Faculty. The Research Areas cross disciplinary boundaries to conduct rigorous and relevant research in common research topics.

### About the Program

The course program will start in October 2019. During the first year, students will take part in courses on multi-disciplinary methods and theories, and subject-specific courses. During the second and third year, students mainly conduct research and work on their thesis. Students are encouraged to spend one term abroad.

### Qualifications

We are inviting applications by highly qualified graduates from the fields of Management, Economics and Social Sciences or other related. Candidates must hold a Master's degree (or equivalent) or be very close to completion. The program is taught in English.

### Scholarships

Students accepted to the program receive a scholarship of 1.365 € per month. The scholarship is awarded for a maximum period of three years and is tax-free. Scholarships start with the course program in October 2019.

Application is online only. The deadline for the submission of your application is **March 15, 2019**.
